## **Budget / Staffing / Resource Allocation Discussion**

- 1. Balancing Priorities Does the Council wish to focus primarily on:
  - a. Reacting to initiatives of the Administration, or on enacting Council initiatives, or roughly an equal balance?
  - b. Researching policy priorities of the full Council, or researching policy priorities of individual Council Members, or roughly an equal balance?
  - c. Policy work or constituent work, or roughly an equal balance?
  - d. Analyzing and following-up on land use and planning issues on the Council agenda, or assisting constituents at the request of Council Members on specific land use, housing and planning issues on the Planning Commission, Historic Landmarks, Administrative Hearings, Board of Adjustment, Housing Advisory and Appeals Board, etc. (The specific issues tend to be urgent and have the unintended consequences of diverting time from policy priorities, but the work on the specific issues adds value; we are just searching for options.)
  - e. Doing advance legwork and laying groundwork for the budget process, the agenda process and meetings well in advance of the dates, or delaying advance planning in favor of daily urgent needs. (Advance work reduces the over-all staff time needed.)
  - f. Working on issues over which the Council has budget or policy control vs. issues that are of significant interest, but which are controlled by outside entities including the Federal, State, County governments or private organizations.
  - g. Looking for system solutions vs. dealing with individual system problems. (Tool is audits / studies / consulting but staff time is needed to write scopes.) (Again, the individual issues are urgent and significant; understanding the specifices does help us address the system, policy and budget issues. It is just important to recognize that the specific problems divert policy resources from work.)
- 2. Can we streamline or cut out some tasks? Some tasks are more time consuming than one would think. The Council could weigh the tasks and determine whether they would like the time spent on these items or diverted to other priorities. Staff recognizes that EVERY one of these tasks adds value; we are just searching for options.
  - a. Consider handling pledge the same way at District Meetings as at regular Council meetings rather than arranging for boy / Girl Scout troops at community meetings.
  - b. Induction ceremony / function for outgoing Council Members
    - i. Mailing of induction invitation to all board members, community leaders, elected officials. (Some other local governments use a press release rather than formal invitations)

- ii. Evaluate formality of mailing of invitation for out-going Council Members' reception and Induction to community members, elected officials etc.
- iii. Food service at Induction (some jurisdictions do not provide food)
- iv. Scope of function for out-going officials
- v. Oath of Office arrangements if by other than City Recorder.
- c. Arranging meetings with community groups on issues that are of significant community interest outside of the Council's purview.
- d. Resolutions that do not have a Council sponsor.
- e. Evaluate the number of and process for district meetings and outreach meetings.
- 3. Other ideas to prioritize or better use resources?
