DISCUSSION:

**Issue Origin:** In an attempt to maintain consistency for the voters of Salt Lake County, Attachment "A" is submitted with a resolution of acceptance for the City Council's consent. Attachment "A" lists consolidated precincts and facilities for polling places in Salt Lake City that meet ADA requirements, have adequate parking and have the potential to be used for future elections.

**Analysis:** Salt Lake County as the contracted election officer for Salt Lake City has submitted this list of polling locations that will be used in County-wide elections as well as municipal elections.

**Recommendation:** That the Resolution be placed on the City Council's consent agenda as a matter of house keeping for the 2009 Primary and General Municipal Elections.

WHEREAS, Section 20A-5-403(1)(b) Utah Code Ann., as amended, requires each election officer to obtain the approval of the Salt Lake City Council (the "City Council") for those polling places; and

WHEREAS, the City Council desires to comply with said statutory mandate and to accept and approve the consolidated precincts and polling locations for the City's 2009 primary and general elections.

NOW THEREFORE, BE IT RESOLVED BY THE City Council of Salt Lake City, Utah that those consolidated precincts and polling locations for the 2009 primary and general elections set forth on Exhibit A are hereby accepted and approved. Exhibit A may be changed as needed without further City Council action. Exhibit A shall be made available for inspection, examination, and copying during business hours at the office of the City Recorder.
